1. 申請注意事項 Application Instructions

1.1. 修業年限 Program Duration

學士班修業年限為 4-6 年;碩士班修業年限為 1-4 年;博士班則為 2-7 年。

Once being officially enrolled, students must complete their undergraduate program within 4-6 years. Likewise, Master's programs must be completed within 1-4 years and PH.D programs within 2-7 years.

The postmark deadline is March 15, 2019. Applications postmarked after March 15, 2019 will not be processed. Furthermore, we highly recommend that you submit your application by using a trackable global delivery method, such as the ones offered by DHL, FedEx, Express Mail, or UPS. However, shall you decide not to submit your application via a trackable carrier, please ensure to mail your application as early as possible in order to avoid complications.

Applications submitted in person are accepted Monday through Friday (except holidays), 9am – 12pm and 2pm – 5pm. Applications not submitted during the specified hours or late applications will not be accepted. Please contact the OIC for the respective NCCU holidays.

Once the OIC has received the application packets, a confirmation e-mail will be sent to the applicant within the next 7 working days. If a student is applying to more than one program, applicants shall put the applications into separate envelopes (each with the respective application cover sheets printed from the online application system on top). However, the applications can be submitted together in a single packet.

1.4. 申請資格 Eligibility

(1) 外國學生身分 Definition of International students

外國學生定義如下:

International students are defined as follows:

- ①具外國國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者。
 - Those who have foreign nationality and have never held R.O.C. nationality and also who do not possess overseas Chinese student status at the time of their applications.
- ②具外國國籍,於申請時已連續居留海外(不含香港、澳門及大陸地區)六年以上(計算至 2019 年 8 月 1 日且每曆年在臺灣停留時間不超過 120 日)並符合下列規定者:
 - Those who have foreign nationality and have resided overseas (excluding Mainland China, Hong Kong, and Macau) for more than 6 consecutive years prior to August 1, 2019, and whose stays in Taiwan per calendar year do not exceed a total of 120 days, must fulfill the following requirements:
- a.申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
 - In possession of R.O.C. nationality at the time of application, but have never held household registration in Taiwan since birth.
- b.申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華民國國籍之日起至申請時(計算至 2019 年 8 月 1 日)已滿八年。
 - In possession of R.O.C. nationality prior application, but ceased to possess the nationality for at least 8 years since the date on which a revocation was issued from the Ministry of the Interior, up to August 1, 2019.
- c.前二款均未曾以僑生身分在臺就學,且未於 108 學年度經海外聯合招生委員會分發。 In either of the cases as described in the preceding two paragraphs, those who have studied in Taiwan under the status of an overseas Chinese student and those who have been admitted through admission placement by the University Entrance Committee for Overseas Chinese student in 2019 should be excluded.
- ③ 具外國國籍且原具中華民國國籍,並於 2011 年 2 月 1 日前已提出申請喪失中華民國國籍滿八年者(計算至 2019 年 9 月 15 日)。
 - Those who once had R.O.C. nationality and applied to renounce R.O.C. nationality (prior to February 1, 2011) for at least 8 years since the date, on which a revocation was issued from the Ministry of the Interior, up to September 15, 2019.
- ④具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外(不含大陸地區)連續居留滿六年以上(計算至 2019 年 8 月 1 日且每曆年在臺灣停留時間不超過 120 日)。
 - Those who have foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, but have never held household registration in Taiwan since birth at the time of application, have resided in Hong Kong, Macau, or overseas (excluding Mainland China) for more than 6 consecutive years prior to August 1, 2019, and whose stays in Taiwan per calendar year do not exceed a total of 120 days.

⑤曾為大陸地區人民且具外國國籍,且未曾在臺設有戶籍,申請時已連續居留海外(不 含香港、澳門及大陸地區)六年以上(計算至 2019 年 8 月 1 日且每曆年在臺灣停留 時間不超過 120 日)。

Those who were the former citizens of Mainland China and currently have foreign nationality, but have never held household registration in Taiwan since birth at the time of application, have resided overseas (excluding Mainland China, Hong Kong, and Macau) for more than 6 consecutive years prior to August 1, 2019, and whose stays in Taiwan per calendar year do not exceed a total of 120 days.

⑥依教育合作協議,由外國政府、機關、學校遴薦來臺的外國學生,其自始未曾在臺設 有戶籍且經主管教育行政機關核准者。

Those who have been selected by a foreign government, organization, schools or educational/cultural group according to the Education Cooperation Framework Agreement and do not hold the household registration since birth as well as receive the approval from the designated authorized government educational institutions.

Regarding the calculation of the duration of overseas residence, NCCU conforms to Article 2 & 3 of "Regulations Regarding Students Undertaking Studies in Taiwan" formulated by the Ministry of Education (Regarding the said Regulations, please refer to http://law.moj.gov.tw/).

R.O.C. nationality mentioned above is defined in accordance with Article 2 of Nationality Law. (* see below)

中華民國國籍法,第二條:

有下列各款情形之一者,屬中華民國國籍:

- 一、出生時父或母為中華民國國民。
- 二、出生於父或母死亡後,其父或母死亡時為中華民國國民。
- 三、出生於中華民國領域內,父母均無可考,或均無國籍者。

四、歸化者。

前項第一款及第二款之規定,於本法修正公布時之未成年人,亦適用之。

According to Article 2 of the Nationality Law, a person shall have the nationality of the Republic of China under any of the conditions provided by the following subparagraphs:

- i. His/Her father or mother was a national of the Republic of China when he/she was born. *The situation of mother does not apply to those who were born before February 9 (including the 9th), 1980.
- ii. He/She was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
- iii. He/She was born in the territory of the Republic of China, and his/her parents can't be ascertained or both were stateless persons.
- iv. He/She has undergone the nationalization process.

Preceding subparagraph 1 and subparagraph 2 shall also apply to the persons who were minors at the time of the revision and promulgation of this Act.



(2) 學歷 Educational (or academic) background

A. 符合教育部採認之高中、大學或獨立學院畢業者 (請參考教育部網站 http://www.edu.tw/)。申請學士班者需具高中畢業或以上學歷、申請碩士班者需具大 學畢業或以上學歷、申請博士班者需具碩士畢業或以上學歷者。

Applicants who have graduated from a high school, college, or university recognized by the Ministry of Education of Taiwan can apply for admission (please refer to the website http://www.edu.tw/). International students with a high school diploma or above are eligible to apply for undergraduate programs; bachelor's degree or above for Master programs; and Master's degree or above for Ph.D. programs.

B. 符合教育部「入學大學同等學力認定標準」之同等學力資格者。

Applicants with equivalent qualification stipulated in "Standards for Recognition of Equivalent Educational Levels for University Admission" by the Ministry of Education.

※畢業年級相當於臺灣高級中等學校二年級之國外或香港澳門地區同級同類學校畢業 生得申請本校學士班,惟入學後依本校學則規定應增加畢業學分數 12 學分。

Those having completed study at an equivalent foreign or Hong Kong/Macao high school which is equal to the sophomore of a senior high school in Taiwan may apply to the undergraduate program at NCCU, however, according to "NCCU Study Regulations", their required number of credits for graduation shall be increased by 12 credits to complete their study.

Current graduates (who have not yet received their official diploma) are required to submit an official certificate of expected graduation (in English or Chinese) issued by their school in lieu of their diploma at the time of application.

Admitted applicants can enroll only after they have submitted the photocopies of their diploma, certificate of degree conferral (applicable to applicants with a bachelor's degree or above from an institution in Mainland China, which is specifically recognized by the MOE) as well as a full academic transcript and other relevant academic certificates. In addition, all of them must be verified by the related offices according to the following regulations.

The students whose degrees are conferred by foreign schools (excluding the schools in Hong Kong, Macau, and Mainland China) shall follow the "Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education." The diploma and the full academic transcripts are required to be verified by the Taiwan Overseas Representative Offices in the country in which the degree-issuing school is located.

If the certificate is not in the name of the applicant himself/herself, a signed sponsorship letter (in Chinese or English) is required. In this sponsorship letter, the relationship between the sponsor and the applicant has to be stated and the support of the applicant's expenses for the duration of the applicant's studies in Taiwan has to be guaranteed.

According to the regulations announced by the Ministry of Education on August 4, 2010, the Test of Proficiency-Huayu (TOP) has since changed its name to "Test of Chinese as a Foreign Language" (TOCFL). In addition, a new version of the Test has been instituted since 2011. Students enrolled in departments or graduate institutes requiring a TOCFL level higher than Level 2 need to fulfill the requirements outlined in the regulations of the departments or the graduate institutes before graduation (please refer to section 1.13 for an overview of the respective Chinese Language Requirements).

According to Article 4 of NCCU's Admission Guidelines for International Students, newly admitted students, excluding those students who are enrolled in English-taught programs, are required to pass Level 2 of the Test of Chinese as a Foreign Language (TOCFL). Students failing to acquire a TOCFL certificate of the required level must take and pass 4 semesters of NCCU Mandarin Special Courses (one course per semester) at their own expense before graduation in order to meet this requirement. Students enrolled in departments or graduate institutes which require a TOCFL level higher than level 2, need to satisfy the requirements outlined in the regulations of their individual departments or the graduate institutes before graduation.




